Report on the audit of the Financial Statements

Opinion

We have audited the statement of receipts and payments ("the Statement") of Tails of Freedom ("the Company") for the year ended 31 March 2023, and notes to the statement of receipts and payments, including a summary of significant accounting policies.

In our opinion, the statement of receipts and payments presents fairly, in all material respects, the receipts and payments of the Company for the year ended 31 March 2023, in accordance with the receipts and payments basis of accounting described in Note 1.3.

Basis for Opinion

1 Accounting Policies

1.1 Reporting entity

Tails of Freedom is a Company limited by Guarantee incorporated in Sri Lanka on 15th June 2020 having its registered office and principal place of business at 6, Carlwil Place, Colombo 3, Sri Lanka.

1.2 Principal activities

The Company's main objectives are to rescue, rehabilitate and rehome companion animals in Sri Lanka and ensure the welfare of pet animals.

1.3 Basis of Preparation

The Company's policy is to prepare the accompanying statement on the receipts and payments basis. On this basis, revenue is recognized when received rather than earned, and expenses are recognised when paid rather than incurred.

1.4 Significant accounting policies

The accounting policies set out below have been applied consistently to all periods presented in these financial statements.

(a) Receipts

Receipts include donations received directly to the bank account. The Company does not accept any cash donations.

(b) Payments

Payments include the usage of receipts for the purpose described in 1.2 above.

(c) Net income

The net remaining between donation receipts and payment of fees and expenses as provided herein (the "Net Income") shall be used exclusively for purposes mentioned in 1.2 above.
